The Court granted the application intending to extend the claims, objection, and opt-out deadline. However, the Court quoted language in the proposed order denying that aspect of the ex parte application. ECF. No. 205. The Court intended to proceed with the deadlines outlined in the ex parte application. Accordingly, the Court vacates the final approval hearing set for July 10, 2023 and July 24, 2023. The parties are granted an additional 14 days to permit individuals, who were previously omitted from the notice plan due to the de-duping error, to submit claims, objections, or opt-out of the settlement.
